Completed bids in sealed envelopes and clearly marked "**Project Name and number**" must be placed in the Tender box at the Municipal Offices, 18 Old Main Road, Camperdown 3720 by no later than date specified above and there will be no public tenders opening however the register will be published on the municipal website the same day of closing date.

This bid will be evaluated on 2 stages, comprising of a Technical Evaluation process (Functionality Evaluation and bidders must score minimum of 60%) and a Price Evaluation process (Price Evaluation).

Late tenders or tenders received by fax or incomplete tenders will not be accepted. The Mkhambathini Municipality does not bind itself to accept the lowest or any tender and reserves the right to accept any tender or any part thereof, which may result in the acceptance of more than one tender, whichever the case may be. Proof of dispatch of a tender will not be regarded as proof of receipt thereof.

Tenders will be evaluated according to the Council's Supply Chain Management Policy as adopted in terms of Section 111 of the Municipal Financial Management Act, 2003 (Act No 56 of 2003) and relevant regulations. The 80/20 preference point system shall be applicable.
